As result of these lecture series we produced several textbooks for undergraduate and secondary school level. In 1992-1996 we also were involved to school teachers' training activities in cooperation with American National Economics Education Association.

Today I am teaching mostly three-four types of topics like Basic Economics, Macroeconomics, Labour economics and issues of general macroeconomic environment in Estonia (last for MBA and other open university courses)

Recently I have been responsible also for methodology course for PhD students, EU labour market and labour policy course etc.
